INDEPENDENT AUDITOR'S COMPLIANCE REPORT BASED ON AN AUDIT OF GENERAL PURPOSE FINANCIAL STATEMENTS PERFORMED IN ACCORDANCE WITH GOVERNMENT AUDITING STANDARDS

To the Honorable Mayor and
Members of the City Council
City of Kinston, North Carolina

We have audited the general purpose financial statements of the City of Kinston, North Carolina, as of and for the year ended June 30, 1991, and have issued our report thereon dated October 4, 1991.

We conducted our audit in accordance with generally accepted auditing standards and Government Auditing Standards, issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the general purpose financial statements are free of material misstatement.

Compliance with laws, regulations, contracts and grants applicable to the City of Kinston, North Carolina, is the responsibility of City of Kinston, North Carolina, management. As part of obtaining reasonable assurance about whether the general purpose financial statements are free of material misstatement, we performed tests of the City's compliance with certain provisions of laws, regulations, contracts and grants. However, our objective was not to provide an opinion on overall compliance with such provisions.

The results of our tests indicate that, with respect to the items tested, City of Kinston, North Carolina, complied, in all material respects, with the provisions referred to in the preceding paragraph. With respect to the items not tested, nothing came to our attention that caused us to believe that the City had not complied, in all material respects, with those provisions.

This report is intended for the information of management, the cognizant audit agency, other federal and State agencies and the Mayor and City Council. This restriction is not intended to limit the distribution of this report, which is a matter of public record.

INDEPENDENT AUDITOR'S SINGLE AUDIT COMBINED REPORT ON INTERNAL CONTROL STRUCTURE

To the Honorable Mayor and
Members of the City Council
City of Kinston, North Carolina

We have audited the general purpose financial statements of the City of Kinston, North Carolina, as of and for the year ended June 30, 1991, and have issued our report thereon dated October 4, 1991. We have also audited City of Kinston, North Carolina's compliance with requirements applicable to major federal and State financial assistance programs and have issued our report thereon dated October 4, 1991.

We conducted our audits in accordance with generally accepted auditing standards; Government Auditing Standards, issued by the Comptroller General of the United States, Office of Management and Budget (OMB) Circular A-128, Audits of State and Local Governments, and the State Single Audit Implementation Act. Those standards, OMB Circular A-128 and the State Single Audit Implementation Act require that we plan and perform the audit to obtain reasonable assurance about whether the general purpose financial statements are free of material misstatement and about whether City of Kinston, North Carolina, complied with laws and regulations, noncompliance with which would be material to a major federal or State financial assistance program.

In planning and performing our audits for the year ended June 30, 1991, we considered the City's internal control structure in order to determine our auditing procedures for the purpose of expressing our opinions on the City's general purpose financial statements and on its compliance with requirements applicable to major federal and State financial assistance programs and not to provide assurance on the internal control structure.

The management of City of Kinston, North Carolina, is responsible for establishing and maintaining an internal control structure. In fulfilling this responsibility, estimates and judgments by management are required to assess the expected benefits and related costs of internal control structure policies and procedures. The objectives of an internal control structure are to provide management with reasonable, but not absolute, assurance that assets are safeguarded against loss from unauthorized use or disposition, that transactions are executed in accordance with management's authorization and recorded properly to permit the preparation of general purpose financial statements in accordance with generally accepted accounting principles, and that federal and State financial assistance programs are managed in compliance with applicable laws and regulations. Because of inherent limitations in any internal control structure, errors, irregularities, or instances of noncompliance may nevertheless occur and not be detected. Also, projection of any evaluation of the structure to future periods is subject to the risk that procedures may become inadequate because of changes in conditions or that the effectiveness of the design and operation of policies and procedures may deteriorate.

For the purpose of this report, we have classified the significant internal control structure policies and procedures in the following categories:

Accounting controls:

- Revenue/receipts cycle
- Expenditure cycle, purchases/disbursements
- Expenditure cycle, payroll segment
- Financial reporting cycle
- Investing cycle

Administrative controls:

General requirements:

- Political activity
- Davis-Bacon Act
- Civil rights
- Cash management
- Relocation assistance and real property management
- Federal financial reports
- Allowable costs/cost principles
- Drug-free workplace
- Administration requirements

Specific program requirements:

- Types of services allowed or unallowed
- Reporting
- Cost allocation
- Special requirements, if any

Claims for advances and reimbursements

For all of the internal control structure categories listed above, we obtained an understanding of the design of relevant policies and procedures and determined whether they have been placed in operation, and we assessed control risk.

During the year ended June 30, 1991, City of Kinston, North Carolina had one major federal financial assistance program and expended 69% of its total federal financial assistance on the Small Cities Program.

We performed tests of controls, as required by OMB Circular A-128 and the State Single Audit Implementation Act, to evaluate the effectiveness of the design and operations of internal control structure policies and procedures that we considered relevant to preventing or detecting material noncompliance with specific requirements, general requirements, and requirements governing claims for advances and reimbursements that are applicable to each of the City's major federal and State financial assistance programs, which are identified in the accompanying schedule of federal and State financial assistance, and the aforementioned nonmajor programs. Our procedures were less in scope than would be necessary to render an opinion on these internal control structure policies and procedures. Accordingly, we do not express such an opinion.

We noted certain matters involving the internal control structure and its operation that we consider to be reportable conditions under standards established by the American Institute of Certified Public Accountants. Reportable conditions involve matters coming to our attention relating to significant deficiencies in the design or operation of the internal control structure that, in our judgment, could adversely affect the City's ability to record, process, summarize, and report financial data consistent with the assertions of management in the general purpose financial statements or to administer federal and State financial assistance programs in accordance with applicable laws and regulations. These reportable conditions are described in the accompanying schedule of internal control structure reportable conditions.

A material weakness is a reportable condition in which the design or operation of one or more of the internal control structure elements does not reduce to a relatively low level the risk that errors or irregularities in amounts that would be material in relation to the general purpose financial statements being audited or that noncompliance with laws and regulations that would be material to a federal or State financial assistance program may occur and not be detected within a timely period by employees in the normal course of performing their assigned functions.

Our consideration of the internal control structure would not necessarily disclose all matters in the internal control structure that might be reportable conditions and, accordingly, would not necessarily disclose all reportable conditions that are also considered to be material weaknesses as defined above. However, we believe none of the reportable conditions described in the accompanying schedule of internal control structure reportable conditions are material weaknesses.

We also noted other matters involving the internal control structure and its operation that we have reported to the management of the City of Kinston, North Carolina in a separate letter dated October 4, 1991.

This report is intended for the information of the governing board, management, the cognizant audit agency, other federal and State agencies and the Mayor and City Council. This restriction is not intended to limit the distribution of this report, which is a matter of public record.

SCHEDULE OF INTERNAL CONTROL STRUCTURE
REPORTABLE CONDITIONS

Reportable Conditions:

Immaterial Weaknesses

1. Condition: Employees in the Finance Department have access to the personnel master files on the City's computer system.

Recommendation: Access to certain data (e.g. rate of pay) in the personnel master file should be restricted to the Personnel Department.
2. Condition: The City does not maintain adequate control over its coupons for cab fares.

Recommendation: Place coupons in a secured area and limit access to this area to the person held accountable for the coupons.
3. Condition: During our inquiry of the EDP personnel, it was noted that there was a lack of segregation of duties.

Recommendation: Additional controls should be implemented to identify persons accessing the EDP system.
4. Condition: The City does not maintain adequate security over its inventory. Proper documentation is not required to remove inventory from the warehouse.

Recommendations: Access to inventory should be limited to authorized employees and requisitions should be required to remove inventory from the warehouse.

We have audited the general purpose financial statements of City of Kinston, North Carolina, as of and for the year ended June 30, 1991, and have issued our report thereon dated October 4, 1991.

We have applied procedures to test City of Kinston, North Carolina's, compliance with the following requirements applicable to its federal assistance programs, which are identified in the schedule of federal and State financial assistance, for the year ended June 30, 1991:

- Political activity
- Davis-Bacon Act
- Civil rights
- Cash management
- Relocation assistance and real property management
- Federal financial reports
- Allowable costs/cost principles
- Drug-free workplace
- Administration requirements

Our procedures were limited to the applicable procedures described in the Office of Management and Budget's Compliance Supplement for Single Audits of State and Local Governments. Our procedures were substantially less in scope than an audit, the objective of which is the expression of an opinion on City of Kinston, North Carolina's, compliance with the requirements listed in the preceding paragraph. Accordingly, we do not express such an opinion.

With respect to the items tested, the results of those procedures disclosed no material instances of noncompliance with the requirements listed in the second paragraph of this report. With respect to items not tested, nothing came to our attention that caused us to believe that City of Kinston, North Carolina, had not complied, in all material respects, with those requirements.

This report is intended for the information of management, the cognizant audit agency, and other federal and State agencies and the Mayor and City Council. This restriction is not intended to limit the distribution of this report, which is a matter of public record.

INDEPENDENT AUDITOR'S REPORT ON SPECIFIC COMPLIANCE REQUIREMENTS APPLICABLE TO MAJOR FEDERAL AND STATE FINANCIAL ASSISTANCE PROGRAMS

We have audited the City of Kinston, North Carolina, compliance with the requirements governing types of services allowed or unallowed; reporting; cost allocation; special tests and provisions as listed in the Audit Manual for Governmental Auditors in North Carolina, issued by the Local Government Commission; and claims for advances and reimbursements that are applicable to its major federal and State financial assistance program, which is identified in the accompanying schedule of State financial assistance, for the year ended June 30, 1991. The management of the City of Kinston, North Carolina, is responsible for the City's compliance with those requirements. Our responsibility is to express an opinion on compliance with those requirements based on our audit.

We have submitted, under separate cover, the general purpose financial statements of the City of Kinston, North Carolina for the year ended June 30, 1991, and our report thereon, dated October 4, 1991, is as presented in the following three paragraphs.

We have audited the accompanying general purpose financial statements of the City of Kinston, North Carolina as of and for the year ended June 30, 1991, as listed in the table of contents. These general purpose financial statements are the responsibility of the City's management. Our responsibility is to express an opinion on these general purpose financial statements based on our audit.

We conducted our audit in accordance with generally accepted auditing standards. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

In our opinion, the general purpose financial statements referred to above present fairly, in all material respects, the financial position of the City of Kinston, North Carolina as of June 30, 1991, and the results of its operations and the cash flows of its proprietary fund type for the year then ended, in conformity with generally accepted accounting principles.

In addition to having performed our audit in accordance with generally accepted auditing standards, we also performed our audit in accordance with the standards for financial audits contained in the "Government Auditing Standards," issued by the Comptroller General of the United States.

Our audit was made for the purpose of forming an opinion on the general purpose financial statements of the City of Kinston, North Carolina taken as a whole. The accompanying schedule of federal and State financial assistance is presented for purposes of additional analysis and is not a required part of the general purpose financial statements. The information in that schedule has been subjected to the auditing procedures applied in the audit of the general purpose financial statements and, in our opinion, is fairly presented in all material respects in relation to the general purpose financial statements taken as a whole and should be read in conjunction with those statements and related notes.
