Medium General Service**

**Availability**

This Schedule is available for nonresidential service when the Customer's maximum metered demand in two consecutive months is over 30 kW but less than 1,000 kW. Service will be supplied at one point of delivery through one meter provided by the City to record use for monthly billing.

This Schedule is not available for residential or resale service or for breakdown, standby, or supplementary service without prior written approval of the City. Service will be transferred to another applicable schedule if metered demand is below 30 kW for twelve months or above 1,000 kW in two consecutive months.

Generation may not be interconnected to the utility system or operated by the Customer with service provided under this Schedule without prior written approval from the City. The Customer must install equipment acceptable to the City to protect personnel performing maintenance or repairs and prevent damage to electric system facilities prior to receiving approval. The Customer will be responsible for any injury or damage caused by the operation of such generation. The Customer's electric service will be subject to immediate suspension without notice until adequate protection equipment is installed and approval for generation operation is obtained from the City.

**Type of Service**

Service available is alternating current, 60 hertz, single phase 2 or 3 wires, or three phase 3 or 4 wires, at the City's standard voltages. When the Customer desires two or more types of service, the service will be provided in separate accounts.

**Monthly Rate**

Customer Charge (single phase)	\$48.00

All over 2,000 kWh	8.422 ¢/kWh
<b>Demand Charge</b>	
All over 12 kW*	\$6.91 per kW

\*The demand charge will be reduced to \$6.00/kW when average hours use (total monthly kWh use/monthly peak metered demand) is less than 100.

**Three-Phase Service**

The monthly bill computed for single-phase service plus \$24.00.

**Contract Demand**

The Contract Demand shall be the kW of demand specified in the Service Agreement.

**Billing Demand**

The Billing Demand shall be the maximum metered kW during any fifteen-minute interval within the current billing month, but not less than the greater of:

- (A) Fifty (50) percent of the maximum monthly fifteen-minute demand during the preceding eleven (11) billing months; or
- (B) Seventy-five (75) percent of the Contract Demand until such time as the Billing Demand first equals or exceeds the Contract Demand.

**Payments**

Bills are due when rendered and are payable within 20 days from the date of the bill. If any bill is not so paid, the City has the right to suspend service in accordance with its Service Regulations. In addition, any bill not paid on or before the expiration of 20 days from the date of the bill is subject to an additional charge of 1.5% with a minimum of \$5.00 to the balance in arrears.

**Contract Period**

The Contract Period shall not be less than one year.

**Sales Tax**

To the above charges will be added any applicable North Carolina Sales Tax.

**Effective Date**

This was passed by the City Council on October 7, 2025.

Effective for billing rendered on or after October 15, 2025.
