Availability

This Schedule is available as an option, subject to mutual agreement, for electric service normally provided under the City's Residential Service Schedule.

This Schedule is not available for resale service, or for short term or temporary service.

Generation may not be interconnected to the utility system or operated by the Customer with service provided under this Schedule without prior written approval from the City. The Customer must install equipment acceptable to the City to protect personnel performing maintenance or repairs and prevent damage to electric system facilities. The Customer is responsible for any injury or damage caused by the operation of such generation. The Customer's electric service is subject to immediate suspension without notice until adequate protection equipment is installed and approval for generation operation is obtained from the City.

Type of Service

Single-phase or three-phase (where available) alternating current, 60 hertz, is available at one of the City's standard secondary voltages.

Monthly Rate

Basic Charge: **\$14.35⁽¹⁾**

Energy Charge: **7.136 cents/kWh**

Demand Charge: **\$8.98/kW**

(1) For three-phase service, \$11.52 will be added to the Basic Charge for additional facilities cost.

Minimum Monthly Charge

The Minimum Monthly Charge under this Schedule will be \$14.35 for single-phase service and \$25.87 for three-phase service, unless specified otherwise in a service agreement between the City and Customer.

Billing Demand

Billing Demand will be the maximum integrated demand registered in any fifteen-minute interval during On-Peak Hours of the billing month.

On-Peak Hours

On-Peak Hours will be as follows, excluding weekends and holidays ⁽²⁾:

May-September 1:00 p.m.-7:00 p.m. weekdays

October and April 7:00 a.m.-9:00 a.m. and
2:00 p.m.-8:00 p.m. weekdays

November-March 7:00 a.m.-9:00 a.m. weekdays

⁽²⁾ Holidays: New Year's Day, Martin Luther King Day, Good Friday, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Friday after Thanksgiving Day, Christmas Eve, and Christmas Day.

Sales Tax

Any applicable North Carolina Sales Tax will be added to charges.

Payments

Bills are due when rendered and are payable within 20 days from the date of the bill. If any bill is not so paid, the City has the right to suspend service in accordance with its Service Regulations. In addition, any bill not paid on or before the expiration of 20 days from the date of the bill is subject to an additional charge of 1.5% of the balance in arrears with a minimum of \$5.00.

Minimum Term of Service

Service is available on a month-to-month basis, except for a Customer previously served under this Schedule. For any Customer reapplying for Time-of-Use service at the same location, the minimum service term will be one year.

General Conditions

Electric Service is rendered subject to the City's Service Rules and Regulations and normal operating practices. This rate schedule, Service Rules and Regulations, and normal operating practices may be amended from time to time.

Effective Date

This was passed by the City Council on October 7, 2025.

Effective for billing rendered on or after October 15, 2025.
